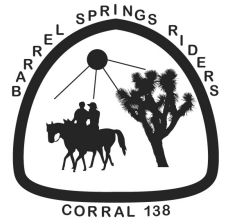

### What Are Trail Trials?

**Trail Trials** are a competition on a marked trail course on mountain trails, park trails, and in desert areas with natural or simulated obstacles that can be found on trails. The ride is usually 2-3 hours long. There is a volunteer judge for each of the 10 to 12 obstacles evaluating safety, performance, and control of each horse & rider team. Scoring is by points; zero is the best with 10 being, well, you need to work on it. Families and friends can ride together at Trail Trials; they only need to separate at each obstacle. Trail Trials are meant to be fun and enjoyable for everyone. There are three divisions: Open, Novice and Junior. Trail Trials are open to all disciplines of riding: Western, English, Gaited and to all breeds of equines from Draft Horses to Mules to Ponies. Any appropriate attire normally worn for trail riding is accepted. Enclosed shoes are required (no sandals or bare feet); boots are recommended. Approved safety helmets are also recommended. Any type or combination of tack may be used, english, western, Australian - a saddle and bridle/bosal/hackamore are a must. Kickers must wear red ribbon in tail.
