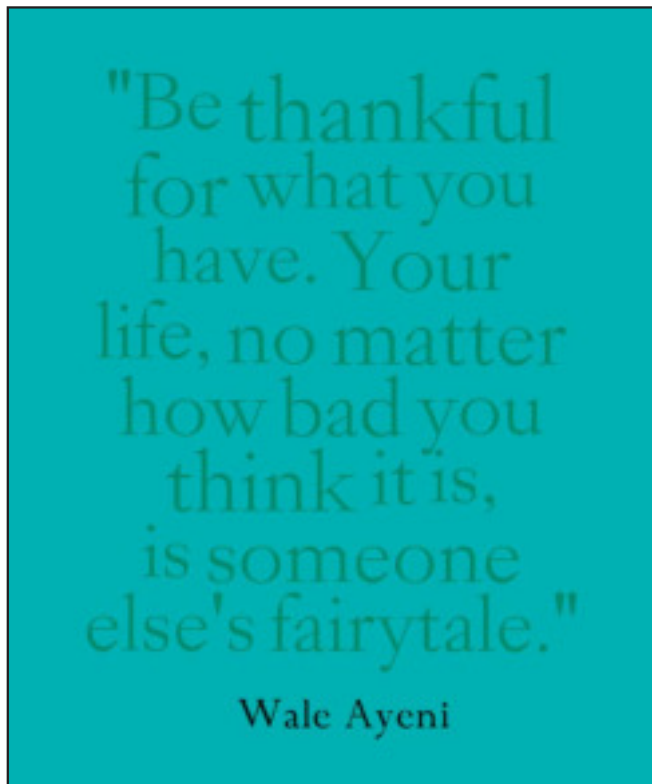

## **Ariel Tram Threatens Horse Keeping** **Submitted by Lynn Brown, ETI National Trail Coordinator**

*I was appointed by L.A. Rec. and Parks to chair an equestrian group of my choice to address the proposed Aerial Tram project. The group was composed of five members of the L.A. Equine Advisory Committee (EAC), an L.A. City appointed committee. Also in the group were four local experienced riders (ETI included) from the Burbank/Glendale/Los Angeles area who regularly ride the trails that are to be impacted in Griffith Park.*

*This was a formal hearing, and the group met to discuss their concerns on this proposed issue. As chair, I was tasked with summarizing the groups concerns. I presented the group's opinions at the EAC meeting September 30. There was a motion from the EAC Board to write a letter, which was approved by vote, and was sent.*

*My summation and comments as chair of the Aerial Tram Equestrian working group:*

Griffith Park is the largest urban park in the U.S. It is the only urban park that features horse trails. A person can ride into the Park and see Glendale, Los Angeles and Burbank spread around the Park. This unique access to the Park must be preserved. To access these trails, riders cross a single protected equestrian bridge over the LA River and travel through dedicated equestrian tunnels at the 134 freeway and in Griffith Park. The quiet nature of this area, in a natural condition (fencing and signs for the arena, all parking areas in a natural unpaved condition) complements the primary equestrian trail into the Park.

At the time of the Equestrian Aerial Tram working group, The Dixon Report and Recommendation were unknown to all but one person in this group. The rest were unaware of the Dixon Study and therefore not afforded any opportunity to read it in the context of the questionnaire. This is a serious oversight

because the Dixon Report recommends Martinez Arena for the Aerial Tram because it is "under-utilized" (a significant misreading of actual service and use of Martinez Arena). With no identification of the study or its recommendations in the questionnaire itself, the equestrian group concluded that, by all appearances, a decision has been likely made, predetermining the outcome of the Aerial Tram location (including a "transit hub" and "visitors center".)

Approximately 20 years ago, Martinez Arena was officially dedicated by then Councilman LaBonge to the general equestrian public. I was present at the dedication along with Councilman LaBonge.

The prime reason given in the Dixon report recommendation was inaccurately based upon a visual survey, lacking deep knowledge of the nature and use of Martinez Arena. Second, Martinez arena serves multiple purposes, and its location on the north entrance to Griffith Park makes it convenient to all of the equestrians from Los Angeles, Burbank and Glendale. To the contrary, it is over utilized with documented use from the horse-keeping public.

Any proposal to urbanize the north entrance to the Park conflicts with the continued safe use into Griffith Park for all equestrians from Los Angeles/ Glendale/ Burbank; and for all visitor-serving facilities from the rental stables in Glendale, LA and Burbank. The equestrian community presence brings financial gain to all ancillary businesses...i.e. tack stores, veterinarians, rental stables for the public, boarding barns for horse owners, and the L.A.E.C. which attracts the general public for public riding lessons and many other events attended by the public. The equestrian public supports the grocery stores, local restaurants and many businesses. Also, the equestrian public has a huge effect on real estate value and prices and on the local

economy because of access to the Park.

The business done in the equestrian area amounts to several million dollars annually as many equestrians shop and do business in the area after riding.

Tram noise, busses, cars, shuttles are antithetical to the quiet nature of the north entrance. The equestrians from the adjoining cities will be put at unnecessary noise and risk. They have no options as equestrians have only one access to ride in the Park. Riders must go over the Mariposa Bridge, the only equestrian bridge in this area, and must pass by Martinez to access the 54 miles of wonderful trails in Griffith Park. This action disenfranchises a large profitable, peaceful, non-destructive group of Park users.

The proposal at the north entrance puts visitors at a disadvantage. It is a single purpose location disconnected from many of the Park's other more urbanized activities. Because the trails are part of the Cultural Historic Monument status of Griffith Park, the trail riding experience is to a quiet, natural and safe

environment at the west entrance.

Introducing a transit hub, a visitor center and aerial tram conflicts with the historic status of the trails, the Park and its wilderness values.

The on/off ramps at Forest Lawn Drive are inadequately one lane, to accommodate the expected volume of buses, shuttles and cars. Significant conflicts at these ramps occur regularly with memorials, funeral processions and remembrances of those buried at Mt. Sinai and at Forest Lawn.

The Park is zoned Open Space and a Historic Cultural Monument. The north entrance is natural and a gateway to wilderness.

The LAEAC will, as it receives additional community input and information concerning a possible transit hub serving Griffith Park, provide continuing input as part of the feasibility study. We believe the ideal location for any transit hub/ tram within the Park should be within the Park itself.

# Fall Horse Treats

## Pumpkin Cubes

### Ingredients:

- 1 small pumpkin
- 1tbsp cinnamon
- 18oz jar of oats
- 1/4 cup molasses
- 1/2 cup brown sugar

### Directions:

Preheat oven to 400.

Cut pumpkin (w/o string, seeds, or rind) into cubes.

Put pumpkin into large saucepan w/ enough water to cover bottom of pan.

Sprinkle cinnamon on top.

Let cook on medium for 45 minutes or until mushy. stir frequently. let cool.

In large mixing bowl (you may need two), mix oats, brown sugar, molasses, and pumpkin mix.

Roll into small balls and place on cookie sheet. if not thick enough, add molasses.

Put in oven for 12-15 minutes.

Let cool.

Freeze extras so you have some for later!

## Fall Pumpkin Cinnamon Horse Cookies

### Ingredients:

- 1/2 can of pumpkin
- 1/4 cup of molasses
- 1 tbsp cinnamon
- 1/2 cup of brown sugar
- 2 1/4 cups of oats

### Directions:

Preheat oven to 400 degrees, and grease a cookie sheet or two, if you need to.

In a large mixing bowl, combine oats, brown sugar, molasses, and pumpkin. Mix until blended.

Roll into small balls with your hands...about 1" in diameter balls for some normal-sized treats. As you go, place these balls on the cookie sheets.

They do not rise or spread or anything, so you can place them as close to each other as 1 1/2 inches or so.

\*\* If you're making your treat balls, and they seem to be falling apart a bit, you can always add more molasses to thicken the 'batter'.

Place into the oven, and let bake for 12-15 minutes, depending on your oven.

Pull them out of the oven. They should be a bit dried out, but still a teeny bit squishy when you poke them a bit. They should not be crunchy.

Before they cool and before you remove them from the cookie sheet, sprinkle the tops of them evenly with the cinnamon.

Bake at 350 degrees for 20 minutes or until done.

1 tsp of Calcium Montmorillonite Clay  
1/2 tsp cinnamon

**Directions:**

Bowl 1 – Thoroughly mix dry ingredients together.

Bowl 2 – Thoroughly mix wet ingredients together.

Add Bowl 1 to bowl 2 and mix well.

Knead on floured surface.

Roll out to 1/2" and cut into adorable shapes with cookie cutters.

Bake at 325F for about one hour or until they reach desired hardness.

Note: If dough is too sticky, add flour.

## ETI National Programs

**Horse Shows** ETI has a National High Point Circuit which is currently on hiatus. Until then, please contact the ETI office. Non-ETI members can participate in our ETI High Point Shows. But to be a part of the National High Point Circuit you must be an ETI member. You can sign up for the Circuit any time during the season, but must compete a specified number of times in your chosen classes to win awards. Points towards year end awards start accumulating on the date you sign up with the high point program.



The **Junior Ambassador Program** is open to all ETI youth age 7 to 21. Boys are welcome for the Prince and King category. Applications for the program may be obtained by contacting Cheri Ovayan at (818) 335-2884 [covayan97@icloud.com](mailto:covayan97@icloud.com). The completed forms are due back by April 2<sup>nd</sup> with all fees, sponsors, autobiography and pictures. This is a great way for our youth to represent their Corral and ETI. Participants volunteer their time at several mandatory events as well as many horse shows; trail trials, parades, trail dedications, quarterly dinner meetings and fun events just for the Junior Ambassador Court such as the retreat! **Trail Rider Award Program** (TRAP) keeps computerized logs on how many hours members are riding. In this day and age, when trails are giving way to housing developments, it is crucial that records be kept on trail usage. ETI Corrals in all areas are finding themselves having to defend their



riding areas more and more against encroaching civilization. On several occasions, TRAP records have been instrumental in maintaining trail access.

ETI TRAP acknowledges hours in the saddle with shoulder patches & pins that can be attached almost anywhere. The fee to join TRAP is only \$12.00 (you must maintain current ETI membership); then the TRAP membership is maintained each year for only \$6.00. You will start by receiving the TRAP main shoulder patch and your log sheets. As you achieve the hour goals additional patches will be sent to you. Carol Elliott is the TRAP chair. **Trail Trials:** An ETI Sanctioned Trail Trial consists of a trail ride, usually averaging between two and three hours, with trail obstacles along the way. Obstacles are natural, or simulate naturally occurring conditions for the horse and rider to negotiate. We now have a DVD from a clinic demonstrating obstacles and tips to compete or put on a Trail Trial. It is important to remember that the people doing the judging at sanctioned Trail Trial event are volunteers following the rulebook and are doing the best they can. Safety, control, and common sense are the number one priorities for all ETI sanctioned Trail Trials. Trail Trials are open to ETI members and Non-members. There are three divisions: Juniors for youth 14 years (as of Jan. 1st) and under; Novice and Open.
