





It's TRAP! What is "TRAP" you ask? TRAP is ETI's Trail Rider Award Program!



What does it do? A heck of a lot more than it sounds!

All your TRAP dues of \$6.00 are due in January.

ETI TRAP keeps computerized logs on how many hours members are riding and where.

In this day and age, when trails are giving way to housing developments, it is crucial that records be kept on trail usage.

ETI Corrals in all areas are finding themselves having to defend their riding areas more and more against encroaching civilization. On several occasions, TRAP records have been instrumental in maintaining trail access.

When a Corral calls ETI TRAP and identifies a specific problem area, TRAP not only provides them with actual riding statistics of usage, but TRAP members are notified to increase usage and support in that particular area.

Documentation from 'trail logs' turned in by TRAP members are proof that trails are being used by equestrians.

ETI TRAP acknowledges hours in the saddle with shoulder patches and pins that can be attached almost anywhere.

Lest we offend the "cart" people, TRAP also counts those non-arena hours of driving time spent on the trails.

How much does all this cost? It's cheap!!! The fee to join TRAP is only \$12.00 (you must maintain current ETI membership); then the TRAP membership is maintained each year for only \$6.00.

You will start by receiving the TRAP main shoulder patch (about the size of a police patch), and your log sheets. As you hit the hour goals (100, 200, 500, etc.), additional patches will be sent to you. When you reach the higher levels, your hours will be acknowledged with pins instead of patches.

There was a short drive scheduled for Friday for those who wished to arrive early, then Saturday was to be a longer drive/ ride and on Sunday a shorter drive/ride. Friday was hot with a strong wind blowing. Linda Elder arrived in the morning followed by Sue Martzolf in the early afternoon. At approximately 5pm, Jim Porter led out with his team of mules, Mandy and Sandy, with Linda Elder as swamper. Sue Martzolf followed with her three up of Haflingers, Duke, Dan and Bud, while Julie Porter, riding Mystery and Faith Kirby, a young friend of the Porter's, riding Mooner were outriders. Jim drove part of the planned route for Saturday which was south of Hwy 178. He pointed out where storm Hilary had flooded and washed tons of sand across the area, and said he wanted to avoid the deep sand on Saturday, because it is difficult for the stock to pull wagons through it, especially carts with narrow wheels. He drove about 1 hour and 15 minutes for a total of four miles. By the time we got back to camp, more people were arriving. The wind continued to blow all night, but it did help to cool it off a little.

Saturday morning dawned with the wind still blowing, but not as bad as Friday and the temperature seemed as if it was not going to be as hot. Start time for the drive/ride was set for 9:30am, and Jim

Porter was ready and waiting to lead out the five other wagons and the six outriders, as we all fell into line to start out. Linda Elder followed Jim driving her Arabian mare, Shaba, then came Jeanette Hayhurst driving her mini's, Lena and Harley, while ponying her mini, Levi. Wes Alcott with his team of mules followed by his mother, Sue Martzolf, driving her team were next and then Dolly Kouri with her two dogs, Tom and Ben, and driving her mule, Dandy. Julie Porter, Faith Kirby, Lyn Engels, riding her mule Duke, Rick Engles, riding his mule Rose, Wendy Bailey riding the horse, Bella, and Vicki Rausch riding her horse, Barbie, were outriders. The first loop we stayed south of Hwy 178, making a large loop of 6.7 miles for 2.45 hours, and returned to the ranch for a one hour lunch break. Due to the large amount of rain, there was a lot of vegetation and some of the trails we drove were very hard to see. I joked with Jim that he just wanted us to blaze new trails for him.

10 DIY Horse Treat Recipes Your Horses Will Love By "My Life Is Better With Horses"

Horses, like humans, have a sweet tooth. Treats are a great way to reward your equine friend for good behaviour or to just show some love. However, store-bought horse treats can be expensive and may contain ingredients that are not healthy for your horse.

But when you wanna spruce things up a bit, such as for a birthday or a special occasion, you can easily make some treats at home! Remember that these are treats, to be given occasionally, not a replacement for a healthy, species-specific diet!

1) Carrot and Apple Cookies

These cookies are easy to make and packed with nutrition.

All you need are grated carrots, chopped apples, oats, flour, molasses, and vegetable oil.

Mix all the ingredients in a bowl, form small cookies, and bake in the oven for 20-25 minutes at 250° (500°F) (be careful, this depends on the oven). They must be hard, but without being burned.

Your horse will love the combination of sweet and crunchy.

2) Peppermint Balls

Peppermint is a favourite among horses, and these balls are a great way to treat your horse.

Mix crushed peppermint candy, oats, molasses, and vegetable oil in a bowl, form small balls, and chill in the fridge for 30 minutes.



Your horse will love the refreshing taste. Keep your camera ready though, because your horse can pull some funny faces!

3) Banana Oat Cookies

Mash ripe bananas in a bowl, add oats, flour, and honey, and mix well.

Form small cookies and bake in the oven for 15-20 minutes on Bake at 250° (500°F) (be careful, this depends on the oven). They must be hard, but without being burned.

4) Sweet Potato Fries

Cut sweet potatoes into long strips (keeping them as evenly sized as possible), toss with vegetable oil, and bake in the oven for 20-25 minutes at 250°C (500°F).

Sweet potatoes can take high heat, and you might see them and worry they're burned. The browner they are, the crispier they will be, but there is a fine line between browned and

burnt beyond edibility.

Even if they get really dark, they should still be good because of the natural sugars of the sweet potatoes caramelizing. But watch carefully to ensure that they don't go from browned to burned.

5) Cinnamon Carrot Bites

Cinnamon adds a delicious flavour to these carrot bites.

Mix grated carrots, oats, flour, cinnamon, and honey in a bowl, form small balls, and bake in the oven for 15-20 minutes at 250° (500°F) (be careful, this depends on the oven). They must be hard, but without being burned.

6) Peanut Butter and Apple Sandwiches

Peanut butter and apples make a great combination for this sandwich treat.

Spread peanut butter on apple slices and sandwich them together.



7) Oatmeal and Mint Cookies

Mix flaked oatmeal, whole wheat flour and chopped mint leaves, adding water to make a pliable dough you can shape.

Form small balls, and bake in the oven for 10-20 minutes on at 250° (500°F) (be careful, this depends on the oven). They must be hard, but without being burned.

8) Fruit/Veggie Popsicle

This is a great treat for the summer heat.

Mix your horse's favourite fruits and veggies with molasses and water, and throw in the freezer!

You'll need a large plastic container to freeze the treat block in (saving old ice cream tubs is great for this).

You can use apples, carrots, peaches, carrots – whatever your horse likes your you have at hand.

Cut up the fruits and veggies into equal sized chunks.



Mix 2 tablespoons of molasses into a glass of warm water (about 240ml or 8 ounces) and mix until the molasses has dissolved.

Put the fruits and veggies into the freezing container and cover with water. Place in the freezer until frozen.

9) Pumpkin Muffins

Pumpkin is a great source of vitamins and minerals for horses.

Mix pumpkin, oats, flour, cinnamon, and honey in a bowl, form small muffins, and bake in the oven for 20-25 minutes at 175°C (350°F) or until a toothpick inserted in the centre of a muffin comes out clean.

10) Apple Carrot Cake

This cake is a special treat for your horse on a special occasion.

Ingredients:

1 cup grated carrots

1 cup chopped apples 1 cup oats 1/2 cup flour 1/2 cup molasses 1/4 cup vegetable oil Instructions:

Preheat your oven to 175°C (350°C).

In a large mixing bowl, combine the grated carrots, chopped apples, oats, flour, molasses, and vegetable oil.

Mix the ingredients together until they are evenly distributed.

Grease a small cake pan with cooking spray or butter. Pour the mixture into the cake pan, smoothing out the surface with a spatula.

Place the cake pan in the oven and bake for 30-35

minutes or until a toothpick inserted in the center of the cake comes out clean.

Remove the cake from the oven and let it cool for a few minutes.

Once the cake has cooled down, you can serve it to your horse as a special treat.

These DIY horse treat recipes are delicious and easy to make. Your horse will love them, and you'll love the savings. Remember to feed treats in moderation and consult with your vet if your horse has any dietary restrictions.

13 Useful Tips To Help Horses Cope With Fireworks

Horses and fireworks are not a good combination as even the calmest of horses can get frightened by the loud noises and sudden flashing lights. As a result the period around bonfire night can be stressful for horse owners and horses alike.



Dealing with horses and fireworks

- 1. Wherever possible, get in touch with your neighbours to find out if they plan to let off fireworks. If they do, explain the dangers and ask them to set fireworks off in a direction that is well away from your animals. Knowing in advance when fireworks are likely to be set off enables you to prepare.
- 2. Decide whether to stable your horse or leave it in the field. It is sensible to keep your horse in its familiar environment, in its normal routine, with any companions to make it feel secure. If it is usually stabled, keep it stabled. If it is normally out in the field, keep it there as long as it is safe, secure and not close to the firework display area.
- 3. If stabled, check thoroughly for anything that could cause potential injury such as protruding nails and string.
- 4. If your horse is to stay in the field, check that fencing is secure and that there are no foreign objects lying around that they might injure themselves if they run around.

- 5. Ensure that you, or someone experienced, stays with your horse if you know that fireworks are being set off.
- 6. If it is absolutely necessary for you to leave your horse in the care of another person during a firework display, then be sure to leave clear instructions and contact details for both you and your vet should any problems arise.
- 7. If you know your animal will be stressed, talk to your vet about sedation or perhaps consider moving your horse for the night.
- 8. Playing music on a radio positioned outside the stable can often mask sudden noise, distract attention and be soothing.
- 9. Try to remain calm yourself and keep positive, as horses will sense unease in a person and this may make things worse if the horse is startled.
- 10. It may seem common sense but be aware of your own safety; a startled horse can be dangerous so do not put yourself at risk when trying to deal with a spooked animal.
- 11. Don't risk riding when you think fireworks might be set off.
- 12. Check if anyone is planning to have a bonfire near your yard. If so, make sure you have an emergency fire procedure in place. If you have any doubts, talk to your local fire safety officer.
- 13. Make sure that you have adequate third party liability insurance. If your horse is frightened and escapes, causing an accident, then you could be held liable for compensation.



Here we are again galloping full on into fire season. As I am typing this story, The Post fire is burning in the Gorman area. This area is known for some of the most beautiful displays of wildflowers in Kern County. Today it's about high winds fanning the flames, freeway closures, and families being evacuated from their homes to safety. We all need a plan. ETI National News Online does a great job of providing articles to help educate horse owners about evacuation plans, when and how to execute those plans. And be ready. Not just during fire season which seems to be almost year-round but for other emergencies and disasters.

Sometimes disaster comes in a more personal form. As you may have read in previous articles, Corral 83 has lost some members to their passing from this life. Their departure leaves family, friends, pets and equines, feeling a sense of loss. We have wonderful memories of our time with those friends from our equestrian circle. I'd like to share how a person's presence made and impact on our equestrian life.

May 23, 2024, a friend and former Corral 83 member since the 1990's, Linda Wells joined her beloved husband Joe Wells in eternity. She was 80 years old. On June 3, she was interred at Bakersfield National Cemetery, in Arvin, CA. Linda was a tough cowgirl and a fun person to join on a trail ride. Our current membership chairperson, Laurie R-B, told me that Joe and Linda made sure there were lunches served at Corral 83 Poker rides.

As I read Linda's obituary, I learned some things I hadn't previously known. I knew she had a lot of riding experience, but I did not know she had purchased her first horse at age 16, by collecting aluminum cans and saving the money. The determination to make "it" happen was one of Linda's endearing characteristics. If you were having an issue with your mount as you rode with Linda, she was willing to stick with you and help you work through it. Carolyn M, Corral 83 President, shared a story and a photo Linda took while helping Carolyn negotiate one of the creeks, along Chanac Creek trail, in Stallion Springs.

I am pretty sure that Linda thought because I was riding formerly wild mustangs that I was a more accomplished rider. She led me on some challenging rides in Bear Valley Springs. We took off out from her BVS property on San Juan to a trail she called Sycamore trail. She said, "I want to show you a campground up at the top". Away, we went. I don't remember the names of all the trails, but I do recall that most were very technical. At times, I just closed my eyes, gave my horse the freedom to follow Linda & her Missouri Fox Trotter, Honeys Money, with intention.

I continued to ride with Linda and Corral 83 on many more fantastic rides. Wild Canyon was one Linda insisted we try. She took a photo when we got to the bottom of the canvon. Another very technical trail at that time. It's washed out a few times since. It's a trail where breast collars and breeching are quite useful.

Linda had a 20-year career with the Los Angeles County Sheriff Department. She worked as a Bailiff where she came to know a family member of mine, Judy Spencer. Jess and Judy Spencer have ridden with Corral 83 many times over the years. Linda helped Judy find a nice POA pony Judy called Maui. That was another way in which Linda was helpful to her friends. She knew Judy wanted a particular type and size of mount. When Linda learned about Maui, she encouraged Judy to go and look. Sure enough, Judy ended up with a nice trail horse thanks to Linda.

A workday around the Wells Ranch usually involved reconfiguring the corral panels. But she had a tool she said Joe "invented" that made the job easier. Ok, I'll help. Linda was also an avid gardener and very happy to share her produce. Not only did she grow fruits and veggies, but she also had a beautiful flower garden in her front yard.

Linda hosted an ETI meeting/birthday party at her home in BVS. She had wonderful Western Cowboy style in interior design and décor, including the massive Long Horn cattle horns on her mantle. She paid a lot of money for the mantel piece. She commented "when I'm gone, I know all this stuff will end up in some garage sale for \$25." She had an interesting "Shadow Box" glass topped coffee table with

a collection of bits and spurs under the glass. It was an interesting conversation piece. Her place was decorated exactly as I would have done if I had a ranch home in a rural setting. Earth tone tile flooring, neutral color tile counter tops, river rock surrounds the wood burning stove. She and Joe built the surround, hand placing the rocks. She told me about individual rocks that had special meaning. Some of the rocks weren't so cooperative during instillation.

I could share Linda stories all day long, but the story I want to share most is how she can rest in peace knowing that her beautiful tri-colored Missouri Fox Trotter, Honey's Money, got a very soft landing with Corral 83 member Irene W., also a BVS resident. Irene had lost her handsome fox trotter, Mikey, a year ago and still had a gaping hole in her heart that needed filling. In October 2023, Irene brought Honey to live at her house as a temporary foster situation. I mentioned in my November 2023 National News article it was a "failed" foster placement, and she gained a permanent home with Irene and her husband. Irene groomed her, sought vet care for an evaluation, then developed a diet and exercise plan, before taking her for slow walks around the neighborhood. Irene became a blessing for Honeys Money...RIP Linda.

Linda was a member of ETI since 1990 (possibly further back as ETI started using computerized records in 1990), but when I met Linda in 2008, she was the secretary for Corral 83. She reported the club's monthly rides and activities in a cowboy poetry style with an abundance of artistic liberties. I looked forward to hearing her stories. Mishaps on a trial ride became fodder, her poetic material, with such

calamity injected into the story you nearly forgot how close to disaster the rider had strayed. I replaced Linda as Corral 83 Secretary in January 2014. Linda focused on caring for Joe a little more closely. She still enjoyed telling stories at meetings and parties.

One day, Linda asked if I could drive her to Bakersfield's CBCC for a chemo treatment, then insisted we go to Hodels restaurant for lunch afterward. Hodels is a great restaurant that supports local 4-H, FFA and Grange members by purchasing their livestock at the Kern County Fair, and their food is delicious. It was a good day for us. She seemed to be on the road to recovery and in very good spirits. I admired her courage in fighting cancer.

Linda and Joe were very much a part of the Corral 83 family for 30+ years. Linda was the ETI National News Online Magazine Cover Girl September 2016 when she led members on a fall colors ride in Stallion Springs. I see in the photo she had her camera ready. I hope Corral 83 will repeat that ride in her memory, come September or October, as a fall colors ride.







- b. I forever release, hold harmless and indemnify Released Parties from liability for any and all claims, demands, causes of action, damages, injuries or death to me, my minor children, my horse and my property, and legal liability of every nature, including the negligent acts or omissions of any Released Parties, whether known or unknown, anticipated or unanticipated, direct or indirect, arising out of participation in the past, present or future ETI activities (including equestrian activities, such as the riding, use of, or being near, horses, whether at an arena, stable or on a trail ride in association with ETI) and I assume all risks of injury or death as set forth in this release;
- c. I shall not bring any lawsuit, action or proceeding against any Released Parties, even if they engage in negligent conduct; and

3. Activity Risk.

I understand that some ETI activities take place in isolated or wilderness areas over rough terrain, and/or trails of unknown condition and others take place on land or in facilities owned and managed by others from whom such land or facilities are borrowed or rented. I understand that the organizers, workers and members involved in ETI activities are not professionals in the horse industry, or in the planning or conducting of trips or camping events, or in other areas of expertise involved in ETI activities. I also understand that horseback riding is a rugged adventure, recreational sport activity. I am aware that there are numerous obvious and non-obvious inherent risks of serious injury or death, or property damage, to me or my horse, which are always present in ETI activities, on or near horses. I understand that pregnant women are specifically advised not to ride horses. I understand that ETI is a non-profit club of private individuals who have come together to support and enjoy recreation-oriented activities.

4. Nature of Horses.

I understand that no horse is completely safe, and the Released Parties make no representations or guarantees regarding the safety, training or suitability of any horse. Horses are 5 to 15 times larger, 20 to 40 times more powerful, and 3 to 4 times faster than a human. If I fall from a horse to the ground, it will generally be at a distance of 4 to 6 feet, and the impact will injure me. A horse may divert from its training and act according to its natural survival instincts and may abruptly change directions or speed, trip, slip, fall, stop short, shift its weight, buck, rear, kick, bite, spook, or run from what it perceives to be danger if it is frightened or provoked, or for no reason whatsoever.

5. Conditions of Nature & Locations.

I agree that the Released Parties are not responsible for acts, occurrences or elements of nature or a particular location that can injure a person or scare a horse, cause it to trip, fall or react in some other manner. These elements include thunder, lightning, rain, wind, wild and domestic animals, insects, other people and horses, and reptiles which may walk, run, fly near, bite and/or sting a horse or person, irregular footing on groomed or wild land which is subject to constant change according to weather, temperature, natural and manmade objects. The Released Parties have not inspected, and make no representations or warranties concerning the safety or condition of, any trail, camping site, arena and/or other location of ETI events.




pictures. This is a great way for our youth to represent their Corral and ETI. Participants volunteer their Constitution Trails Chief time at several mandatory
